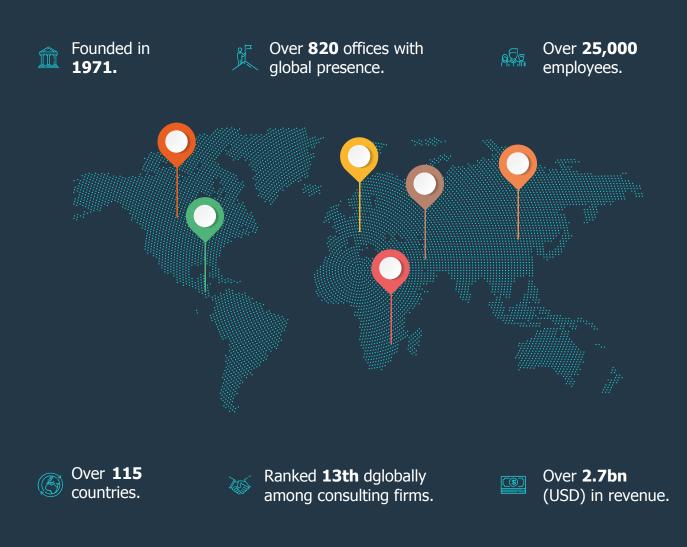

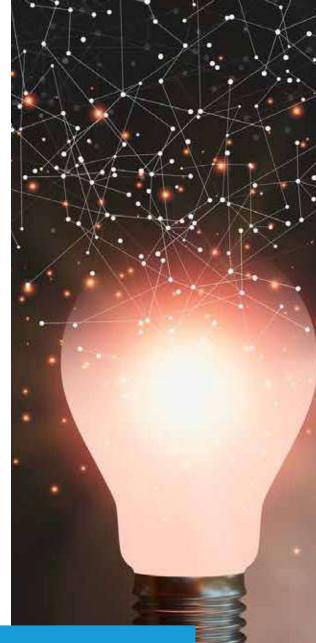

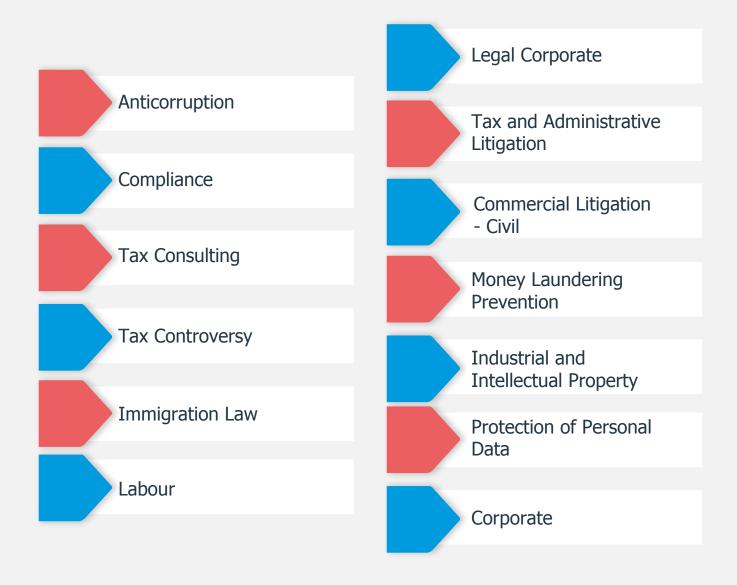

Our Legal Services



The rapid evolution of the national and international regulatory environment requires addressing legal solutions from a holistic point of view and with multidisciplinary teams that allow comprehensive actions to be taken, and appropriate to the business and industry in which legal relation actors, both public and private, are developed.

Therefore, **Kreston BSG**[®]'s legal services offering is developed by high-performance teams with multiplicity of specialties, which prevent contingencies, manage risks and implement effective solutions.

Anticorruption

In addition to the legal commitment that companies must take measures to combat corruption practices, national and international regulation obliges to strengthen internal control so that the action of all those involved with the company is attached to ethical values and principles.

Given the current reality, it is necessary to be clear about the risks that affect each company and how to mitigate them, but in addition it is necessary that legal compliance goes beyond good business management, as it requires extensive legal knowledge, methodologies and adequate technological infrastructure that allow the company to have internal regulatory documents for better decision-making , as well as evidence which may have mitigating or exclusive effects on the criminal liability of the undertaking, among others.

- The imposition of fines or penalties on public servants.

Money Laundering Prevention

All companies are exposed to being used as a vehicle to launder money or resources of illicit origin. If this occurs, the consequences for the organization are not only reputational, but even transcend criminal order and in some cases could lead to the initiation of "domain extinction" procedures; therefore, it is necessary to have an internal regulatory framework that ensures the adoption of actions that prevent such activities.

Moreover, there are companies that carry out activities that are classified by the Federal Law to Prevent and Identify Operations with Resources of Illicit Origin (LFPIORPI or Law) as "Vulnerable Activities"; that is, that activities that are likely to be used to "money laundering".

If an activity is classified as "Vulnerable", in terms of the Law, it is necessary to comply with several obligations such as the preparation of manuals and the submission of Notices to the Authority, which, if ignored, may result in the imposition of administrative fines.

- Consulting. compliance with its obligations to register for the standard of vulnerable activities, as well as in the integration of files and the submission of notices.
- Training. in the matter to the personnel of the company or entity, as well as preparation for the certification that in the prevention of Operations with Resources of Illicit Origin and Financing to Terrorism issued by the CNBV.
- Compliance audits. for vulnerable activities such as the financial sector (we have experts certified by the CNBV).
- Development of manuals, policies and procedures related to the prevention of money laundering and combating the financing of terrorism for vulnerable activities and financial institutions.

- Review of the computer tool used for the prevention of money laundering.
- Legal advice for the development of verification visits or request for information by the SAT, CNBV or the UIF.
- Defense before administrative or judicial authorities for the imposition of sanctions in the matter.
- Legal support for UIF consultations and/or confirmations of criteria.
